Winton Woods High School retains the authority to control student driving privileges. Each permit holder must adhere to the following regulations. Violation will result in loss of the privilege to park or drive on school grounds.

1. Before payment will be accepted for a parking permit, a valid driver's license must be presented and school fees must be paid. Cost of the parking permit is **\$30.00**
2. Student must display permit hanging from the rearview mirror.
3. Student must park only in his/her numbered parking area. Cars parked in spaces other than those designated for student parking may be towed away at the owner's expense or student may lose driving privileges to school. Designated student parking areas will be clearly marked and posted.
4. Keep all unattended vehicles locked.
5. Reckless or careless driving and/or excessive speed (dragging", quick starting) are prohibited on school property and adjacent street areas or other district school property.
6. Speed in excess of 5 MPH is prohibited on school property.
7. Permit holder who lends his vehicle or keys to any other student accepts joint responsibility for any actions of such student while on school grounds.
8. Permit holder may not allow any other student to loiter in his vehicle on school property.
9. Smoking is prohibited in any vehicle that is on school property at any time.
10. No person(s) shall possess, transmit or conceal, use or be under the influence of a drug or harmful intoxicant in any vehicle at anytime on school property. Cars will be searched when there is reasonable suspicion that a controlled substance or alcoholic beverage is present. Cars may also be searched at any other time when the safety or well-being of a student or any other person is involved or if trafficking or any other illegal activity is suspected.
11. Permit holders will be held responsible for irrational actions of any and all passengers in his/her vehicle

- 12. Permit holders will stop for school officials. Permit holders and passengers must follow instructions of school officials.
- 13. Report promptly any change of vehicle or license number to school office.
- 14. It is the student's responsibility to acquaint himself/herself with any changes or additions to driving regulations.
- 15. Cars must be properly licensed and properly insured.
- 16. Radio and/or tape players, set at a volume, which can be heard outside the vehicle, will constitute a violation of the rules and regulations of the parking/driving permit. The violator's parking/driving permit will be revoked for the remainder of the school year.
- 17. The park road parking spaces are for the exclusive use of park patrons. It is not to be used for school parking. Failure to do so will result in enforcement action from the Forest Park police.
- 18. Providing false information will be grounds for forfeiting the driving/parking permit.
